### **Board of Education Proceedings Building & Grounds Committee Agenda May 17, 2021**

The Building & Grounds Committee Meeting of the Board of Education of the Randolph School District was called to order at 4:02 p.m. in the Randolph School District Middle/High School Library by Chairperson Allen Drews.

Members Present – Allen Drews, Gary DeVries, Wayne Vanderploeg, Keith Gundlach

Absent - None

Also present were Business Manager Ryan Cashman, Chuck Drews, Jenny Gaska.

Proof of publication was presented in the form of a Certificate of Proof of Giving Public Notice.

Motion by DeVries, second by Vanderploeg, to approve the Building and Grounds Committee Meeting minutes April 12, 2021. Motion carried.

Old Business - Discussed the following:

- Face Coverings in Summer, Administration recommended no face coverings outside and continue wearing face coverings inside. Will provide an update to the full board after the CDC guideline evaluation.
- Facility Use, no current requests and will continue on the same course.
- Middle School Computer Lab, informed the committee about the plans to eliminate the center section and to use the computer lab as a study area and another option for class space.
- Booster Club Concession Stand Renovation, a request from the Letter Club to add a countertop next to the sink. Mr. Drews will discuss with the Booster Club the exterior door replacement.

New Business - Discussed the following:

- Jovle Land Donation, an approximately 2-acre parcel will be deeded to the Randolph School District on May 21, 2021.
- RELC Washer/Dryer, request to install a stackable washer and dryer that will require building modifications. The committee supports the use of the 220-volt dryer.
- Tree Removal, informed the committee of the removal of several ash trees and discussion to replace the removed trees.
- Parking Lot Resurfacing, recommended for approval at the next full board meeting.
- Furniture for Building, ESSER grant to be used to pay for supplies to complete the list of suggested items by the administration.
- Relamping High School Bids, Mr. Charles Drews relamped the old high school 10 years ago, lamps and ballasts are starting to fail. Vendor present to provide savings feedback. Cost payback over 2 ½ years. Recommended for approval at the next full board meeting
