Mr. Kohn shared that improving ACT and Forward testing scores would be a continuing goal. Literacy and Math will be areas of focus. USA Test Prep was used as an assessment tool. Additional areas reported on include PLC development, incentives, social-emotional learning and at-risk students.

a) Year End Report

Athletics and activities have been very busy and are very well-received by both students and staff. Mr. Propson shared a goal to have 96% of students involved in at least 1 activity at the end of the school year.

4. School Nurse - Mrs. Katie Breitlow

Mrs. Breitlow provided a summary of responsibilities, duties and goals; the services that the school nurse provides is continually increasing. Particularly, COVID was a large part of the 2021-2022 school year. Mental health of students is also an increasing concern.

5. Director of Business Services - Mr. Ryan Cashman

Mr. Cashman reported that the budget year is coming to a close and that Food Service ended the year profitably. Special Education funds are still being worked on. Open Enrollment income fell slightly. A surplus of \$160,000-\$180,000 will be transferred to Fund 46 from Fund 10.

Mr. Vanderploeg handed out some items that he received at workshops.

8. District Administrator - Mr. Ty Breitlow
