- Elementary School Principal Christy Fay: Special Education policies and procedures document. Will be up for adoption on April 20, 2020, meeting. Updated to current DPI standards. The staff is working hard to educate students virtually.
- Middle/High School Principal Andy Kohn: Pass/Fail or Pass/Incomplete under discussion, option for more time for students to complete work under difficult circumstances for only this current situation at this time. Candidates for Graduation 2020 were presented, scheduled for May 29, 2020. Discussed student activities.
- Director of Business Services Ryan Cashman: New law passed on March 18, 2020, for new provision for employee benefits regarding Coronavirus. Salary and benefits unchanged. 2020-2021 salaries and insurance is set. Facility projects originally scheduled for summer are being moved, many will be in this current school year budget, not 2020-2021. Health Insurance 5.5% brought by M3, final 3% increase agreed upon for 2020-2021 and will bid out for 2021-2022. Dental 0% and Vision 0%. Activity Fund Report with Senior Class being reimbursed for most of the expenses from the class trip. Revenue and Expenditure Reports with not much activity. Vouchers are up for approval at the next meeting.
