

Board of Education Proceedings Regular Board Meeting July 15, 2020

The Regular Meeting of the Board of Education of the Randolph School District was called to order at 6:30 p.m. by Board President, Keith Medema.

Reports – Information/Discussion/Action

- Elementary School Principal Christy Fay: Summer School begins on August 4, 2020, with approximately 58 students in 5K-8th Grade, a smaller number of students as expected. Good opportunity to put in place precautions on a smaller scale prior to Fall. Discussed masks, sanitizing, and social distancing.
- Middle/High School Principal Andy Kohn: Speak Up Speak Out fliers were distributed and options to explain and promote this with students still in the planning and will go live September 1, 2020. Middle and High School credit recovery increased their numbers.
- Director of Business Services Ryan Cashman: 2019-2020 Year-End review financials were laid out and recommended that \$200,000 be transferred. Cares Act met with Randolph Christian School last week, increase of School Nurse FTE, \$14,400 spent on supplies for COVID-19 between March and July 2020. Fund 46 recommendations to transfer \$200,000 into Fund 46.
- Activities Director Vince Propson: July Strength and Conditioning had an average of 20 students each day, over 30 for our 5th-8th grade class. WIAA updates given.
- WASB Amanda Meyer: Equity Symposium and Summer Leadership Institute
- CESA 5 Wayne Vanderploeg: Attended a virtual meeting on June 10, 2020, various board members elected.
- District Administrator Ty Breitlow: Homelessness Audit came back "acceptable" with school recommendations.
