WALKING AGREEMENT FOR ADULT COMMUNITY MEMBERS

Hours of community availability are Monday through Friday - 4:00 a.m. to 7:00 a.m. and 6:00 p.m. to 11:00 p.m. Saturday and Sunday - 4:00 a.m. to 11:00 p.m. There may be times that the school is unavailable for walking or using the fitness center due to facility use requests.

The purpose of this form is to allow for the safe and efficient use of the facility for Randolph community members and alumni.

- A. I will use the facility properly and not damage any property. If I discover any damaged property, I will report it to a Randolph school employee no later than the morning of the day following the discovery of the damaged equipment.
- B. I understand there is no food or gum allowed in the facility. Water is the only beverage that will be allowed.
- C. When I am finished walking I will check to be sure that doors are locked and secure and that I have left no trash.
- D. I will be respectful of student and staff use of the facility.
- E. I can expect reciprocal respect from student and staff.
- F. There will be a \$20 fee for the FOB - refundable upon return of FOB. Only one FOB will be given per family.
- G. A \$50.00 fee will be assessed for replacement FOBs.

Consequences of Inappropriate Use:

The use of any district facility is a privilege and not a right. Adults are expected to use the facility in accordance with the above procedures. Failure to use this facility in an appropriate manner will result in the cancellation of use or access to privileges as determined by the administration of the Randolph School District.

I hereby assume full responsibility for any and all injuries, losses, and damages as a result of the inherent risk that I incur while exercising or using the equipment at the Randolph School District.
