Wall Of Fame

The Randolph Board of Education feels it is important to recognize the accomplishments of alumni and therefore established the "Randolph Alumni Wall Of Fame." Those recognized will have demonstrated or contributed to one or more of the following areas: education, business, human services, government, athletics, military service, fine arts, and community service.

The Randolph Board of Education hereby establishes the "Randolph Alumni Wall Of Fame." The policy of the Board is to induct a maximum of three (3) honorees each year as a part of the Honors Banquet. The committee reserves the right to review individuals who may have special circumstances. Honorees shall be recognized with a plaque. The plaque is to be permanently placed on display within the school building. A plaque will also be presented to the inductee or a family representative during the Honors Banquet.

An honoree selection committee will be established as follows: Committee membership shall not exceed eight (8) members; seven (7) voting members and a non-voting chairperson. Committee members will serve a two (2) year term. The chairperson shall be one of the school administrators (District Administrator, Middle/ High School Principal or Elementary Principal). Voting members will be represented as the following:

- 1. Two (2) Randolph teachers selected by the District Administrator.
- 2. Two (2) Randolph Board of Education members appointed by the Board President.
- 3. One (1) Randolph PTO member appointed by the PTO Membership.
- 4. Three (3) Randolph at-large community members. (Community members interested may submit a letter of interest to the District Administrator and the Board of Education. Letters will be reviewed for appointment to the committee as a vacancy occurs.)

Nominations must be received prior to February 1 to be considered for induction at the Honors Banquet. Completed nomination forms and a letter of recommendation must be submitted to the Randolph School District Office. Nominations will stay in the pool of nominees, there is no need to nominate someone each year.

To be considered for this honor; each individual must complete an Application of nomination containing the following criteria:

- Nominees must be a graduate of Randolph High School or an individual who has made significant contributions to the success of the school district of Randolph and the residents of the district.
- Graduates must be a high school graduate of at least 10 years prior to nomination.
- Graduate from high school with a minimum of 10 years before being nominated
- Recommendation letters supporting the individual's nomination.
- Application signed by the person making the nomination.

Nominees for induction must receive five (5) out of seven (7) votes from the selection committee to be accepted as an Honor Wall Of Fame inductee.
